1. Introduction

Merchant Fee Advocate ("MFA") respects intellectual property rights and expects its users to do the same. This DMCA Policy outlines procedures for addressing copyright infringement claims under the Digital Millennium Copyright Act of 1998.

2. Copyright Materials

Protected materials include but are not limited to:

- Website content and design
- Marketing materials
- Training materials
- Partner resources
- Documentation
- Graphics and logos
- Software and code
- Agent and merchant materials

3. DMCA Notice Requirements

To report copyright infringement, provide the following information:

- 1. Physical or electronic signature of copyright owner or authorized agent
- Description of copyrighted work claimed to be infringed
- 3. Description of where the infringing material is located on our site
- 4. Your contact information (address, phone number, email)
- 5. Statement of good faith belief that use is not authorized
- 6. Statement that information is accurate and, under penalty of perjury, you are authorized to act on behalf of copyright owner

4. How to Submit a DMCA Notice

5. Response Procedure

Upon receiving a valid DMCA notice, we will:

- 1. Remove or disable access to allegedly infringing content
- 2. Notify the affected user
- 3. Provide opportunity for counter-notice
- 4. Document all actions taken

6. Counter-Notice Procedure

If content was removed in error, users may submit a counter-notice containing:

- 1. Physical or electronic signature
- 2. Identification of removed material and location
- 3. Statement under penalty of perjury of good faith belief in removal error
- 4. Name, address, and phone number
- 5. Consent to local federal court jurisdiction

7. Repeat Infringer Policy

MFA maintains a repeat infringer policy:

- Account suspension after multiple violations
- Permanent termination for repeat offenders
- Documentation of infractions
- Review of violation patterns

8. Good Faith Belief

- We process notices in good faith
- False claims may lead to liability
- Users are encouraged to seek legal counsel
- Fair use considerations applied

9. Modifications to Policy

MFA reserves the right to modify this policy:

- Updates posted on website
- Users notified of material changes
- Continued use implies acceptance
- Prior versions archived
